Baidenko. – M.: Research Centre for the Problems of Quality in Specialists' Training, 2002. – 408 p.

The proposed collection reflects the complex, systematic and contradictory character of the Bologna reorganizations in European higher school. Russia starts its way in the Bologna reforms not from the "zero mark", but holding the position of a "metasystem" according to the UNESCO classification.

The publication is meant to meet the interests of broad Russian public circles as it touches upon many urgent problems for Russia at the period of its higher education modernization: from establishing a new type of links with economics, labour markets to the questions of higher education systems competitiveness; from elaborating new types of educational programmes (Bachelor / Master) to the problems of forming, implementing and recognizing joint degrees; from introducing ECTS credit systems as new , in principle, approaches to educational programmes projecting to the use of European Diploma Supplement.

As a matter of fact, there isn't a single problem discussed in Russian academic circles, with regard to which approaches and solutions haven't already been formed or aren't being formed at present in the countries of European Union (based on respect to the originality of national education systems).
